2. Ordering and Payment

- 2.2 We accept various payment methods as displayed on the checkout page. Your payment information is transmitted securely using industry-standard encryption.
- 2.3. By placing an order with us you agree that:
 - a) Any information provided by you will be true, accurate, current and complete;
